### Monday, August 1

Depart Little Rock for overnight flight to Rome.

### Tuesday, August 2

Arrive at Rome FCO Airport at 7:15 AM local time and board our motor coach for a bus tour of the Eternal City, stops will include:

- The Tiber Island Church of St. Bartholomew
- Rome's Jewish Quarter
- The Tempio Maggiore di Roma, the largest Synagogue in Rome
- The Basilica of Santa Maria in Trastevere

We will then check-in to our rooms at the Cicerone Hotel. Leisure time for the rest of the day.

### Wednesday, August 3

We begin the day by crossing the border into Vatican City for early morning Mass at St. Peter's Basilica and will spend the morning exploring.

Afternoon we will again board our motor coach and stops will include:

- The Pantheon
- Largo di Torre Argentina Square
- Santa Maria sopra Minerva, the only Gothic church in Rome

Leisure time for the evening.

Day trip to Assisi where we will walk in the footsteps of St Francis and St Claire.

### Friday, August 5 - Feast of Our Lady of the Snows

Motor coach tour including:

- The Basilica of Santa Prassede
- Santa Maria Maggiore for the Solemn Pontifical Mass and the piogga dei fiori (raining of petals)

Remainder of the day at leisure.

### Saturday, August 6

Early morning Mass at St. Peter's Basilica and the rest of the day is currently unscheduled.

- Porta Portese, the largest market in Rome
- Spanish Steps
- Trevi Fountain
- Piazza Navona
- The Coliseum and Forum
- Santa Maria in Aracoeli Basilica
- Mamertime Prison
- Mass at the Church of San Pietro in Vincoli (St. Peter in Chains)

### Monday, August 8

Morning Mass at St. Peter's Basilica, then a tour of the Vatican Museums and the Sistine Chapel. We then will travel to the Papal Basilica of St. Paul Outside-the-Walls. Evening at leisure.

### Tuesday, August 9

Early morning departure for our day-trip to Lanciano, Italy where we will celebrate Mass and visit the Eucharistic Miracle. Return to Rome in the evening.

### Wednesday, August 10

Following early morning Mass at St. Peter's Basilica we board our motor coach to tour Christian Rome.

- The Papal Archbasilica of St. John in the Lateran
- The Scala Sancta (Holy Stairs)
- Basilica of the Holy Cross in Jerusalem housing the relics of the Passion of our Lord
- Basilica of San Clemente

Return to the hotel for a "Farewell to Rome" dinner.
